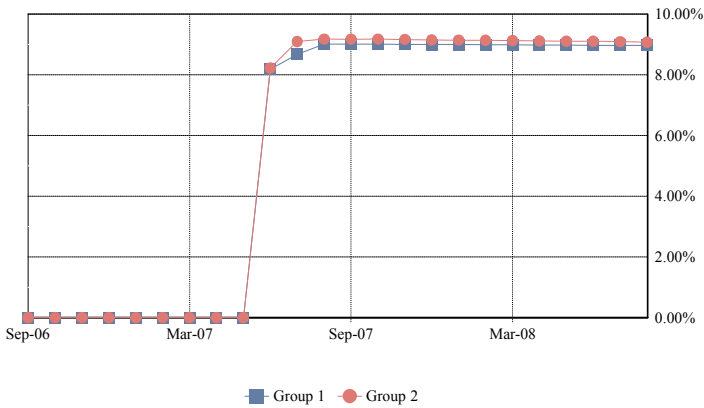

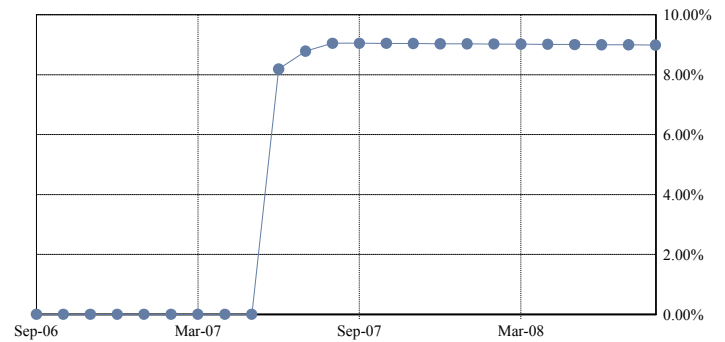

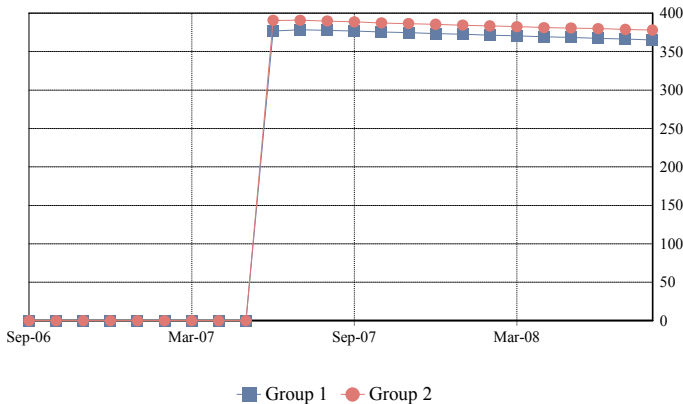
Weighted Average Coupon by Groups



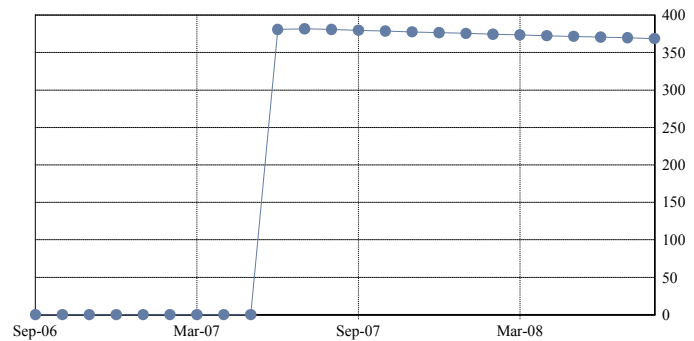
Total Weighted Average Coupon

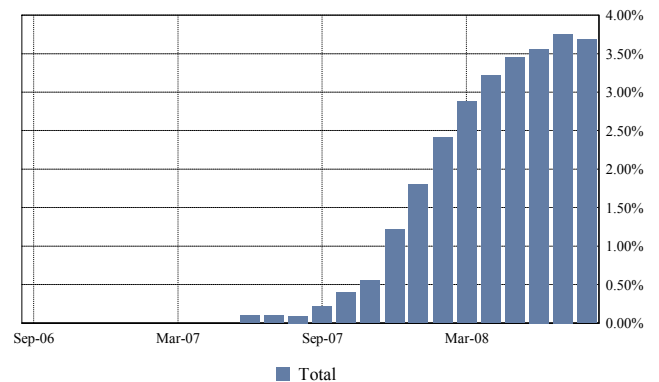

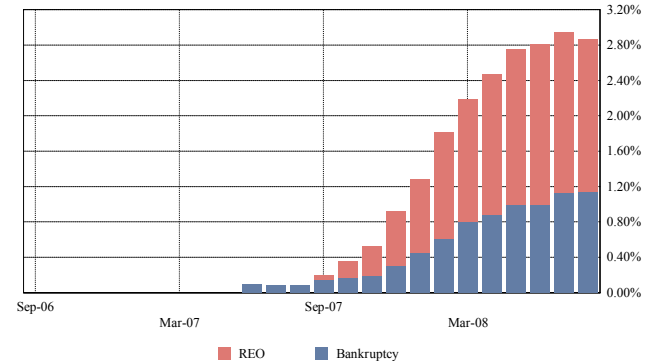

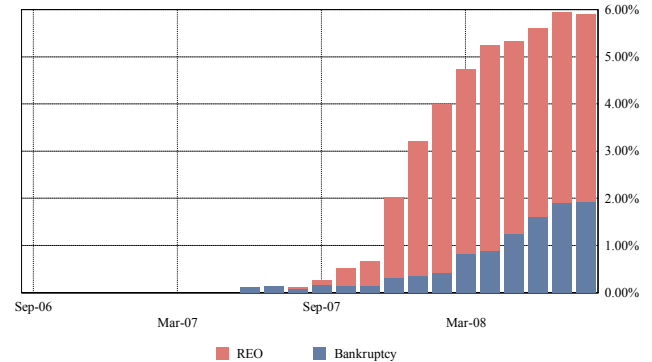
#### 3 or More Payments Delinquent

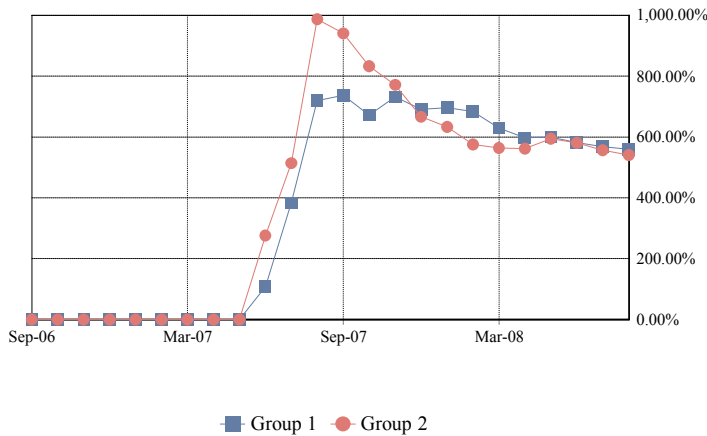
**CPR Avg since Cut-Off by Groups**



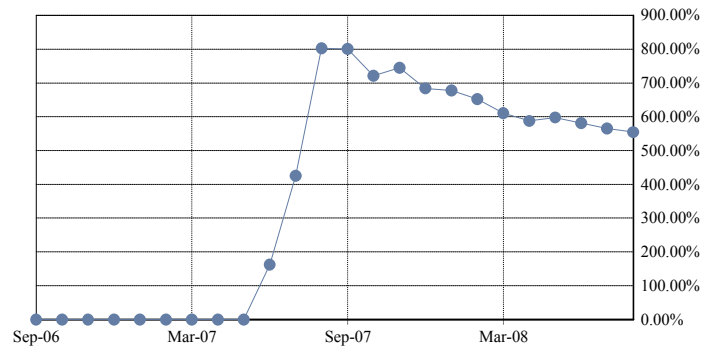

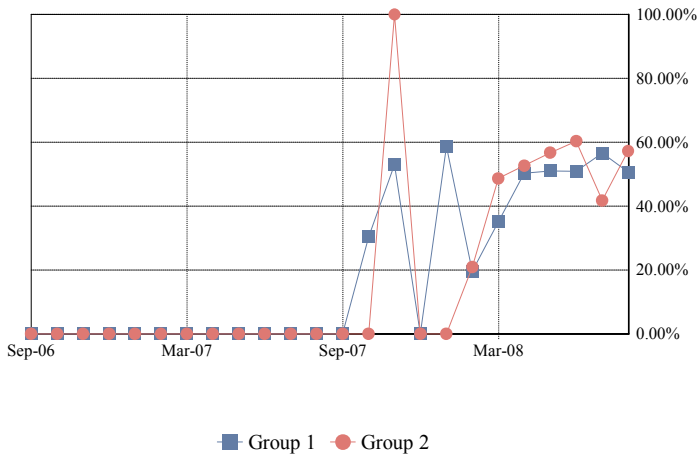

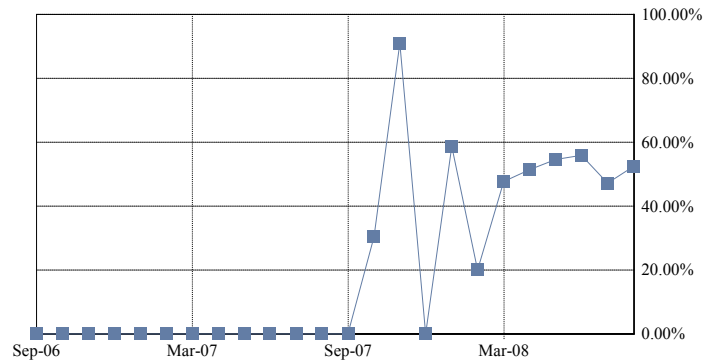

Collateral Loss Severity Approximation by Groups



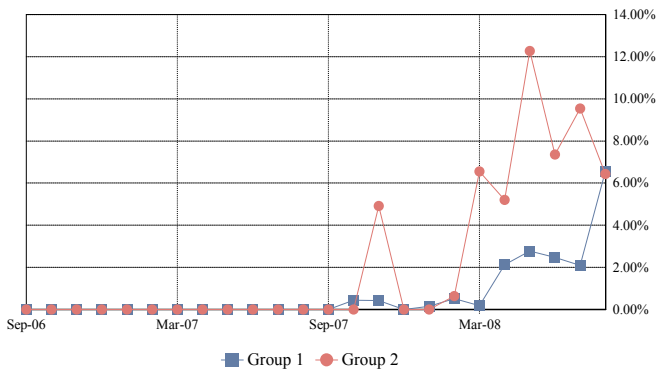
