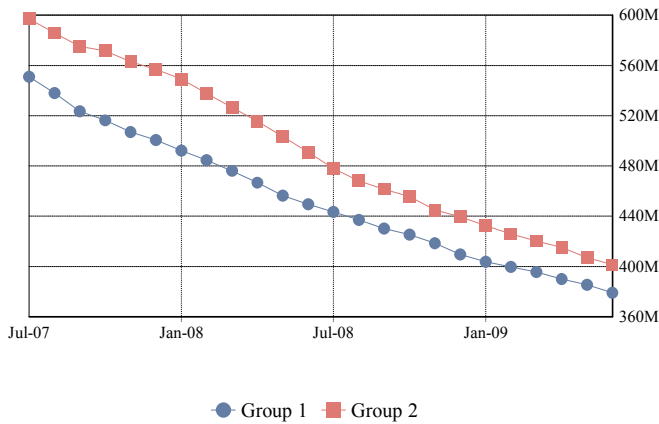

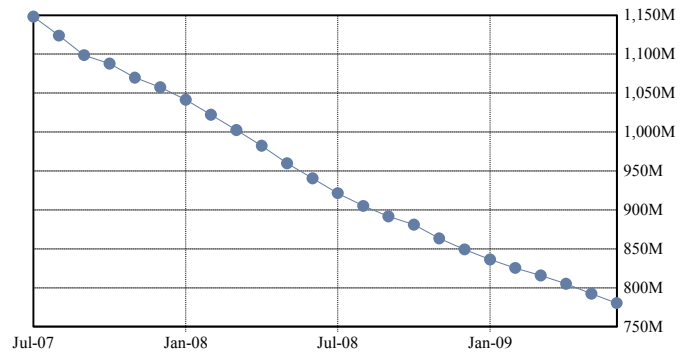

Current Principal Balance by Groups



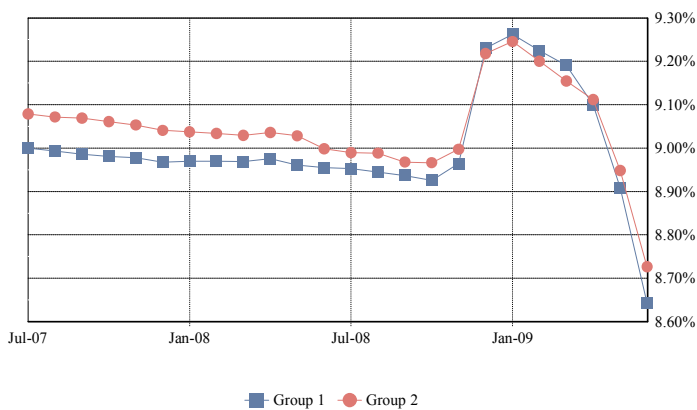

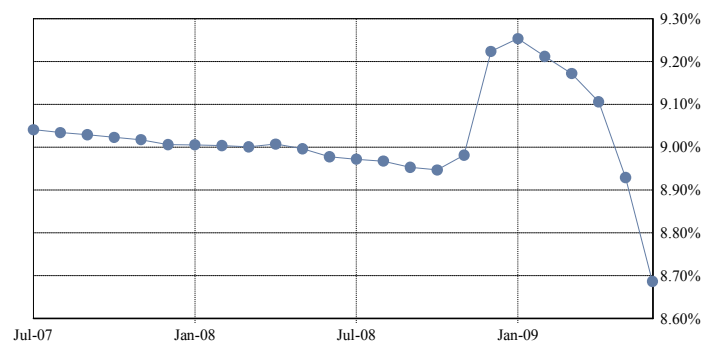

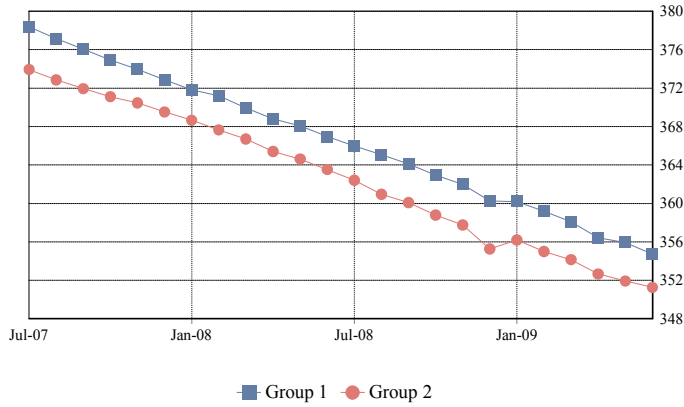
Weighted Average Coupon by Groups



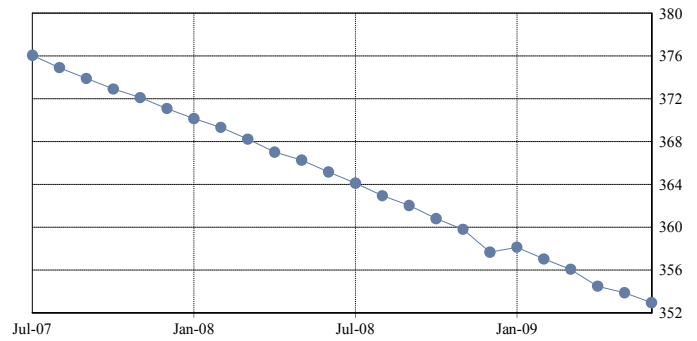
Total Weighted Average Coupon

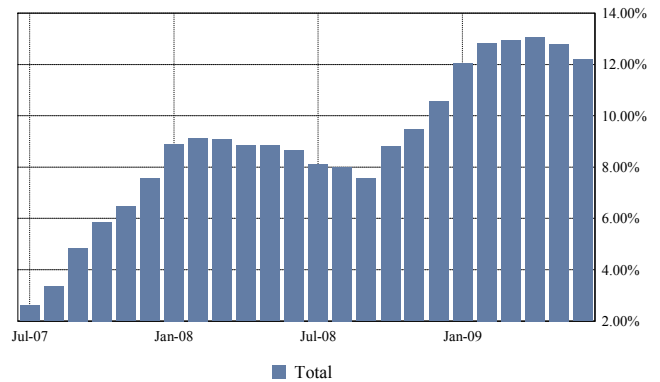

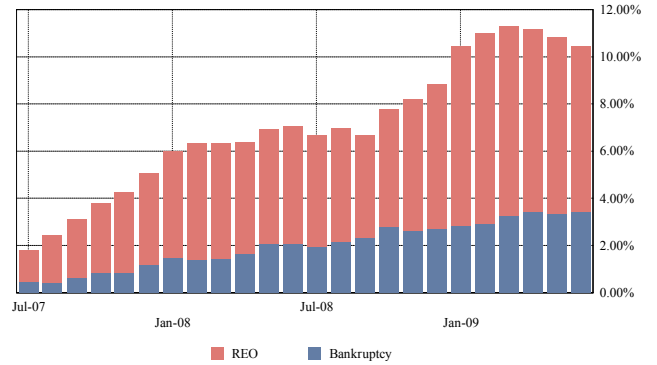

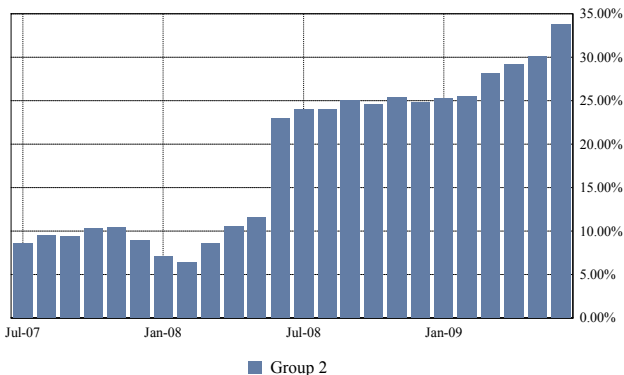

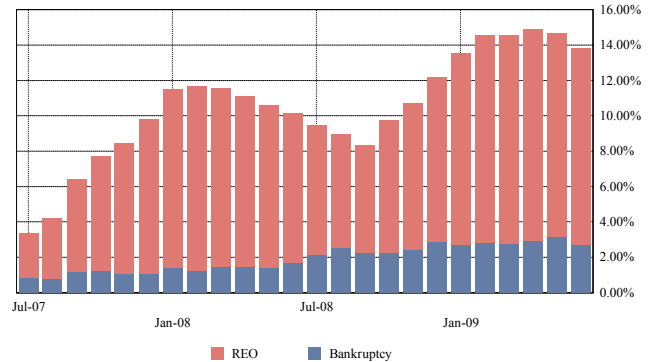

Total Prepayments by Groups



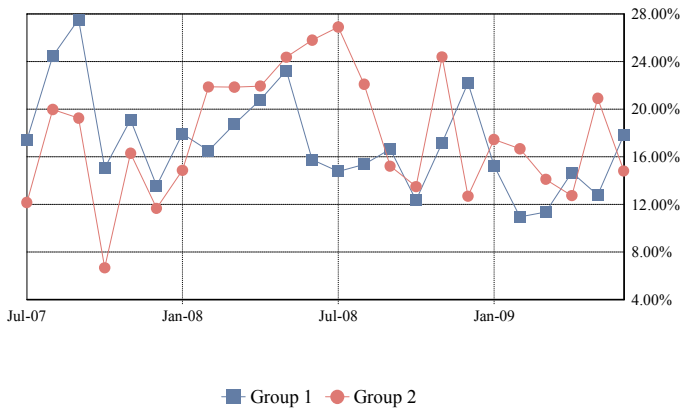

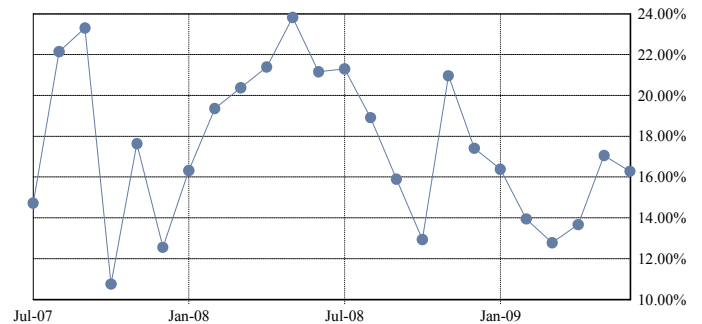

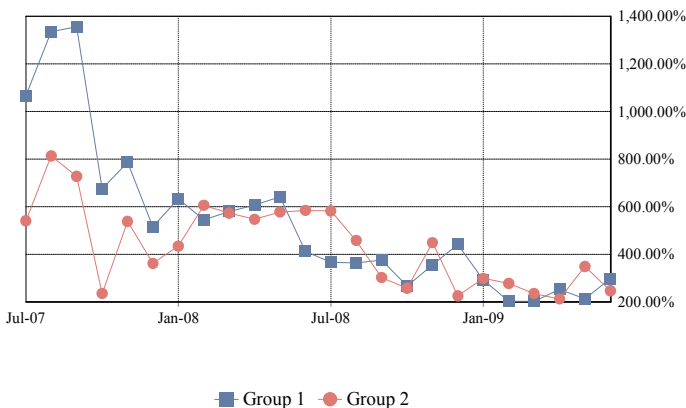
CPR by Groups



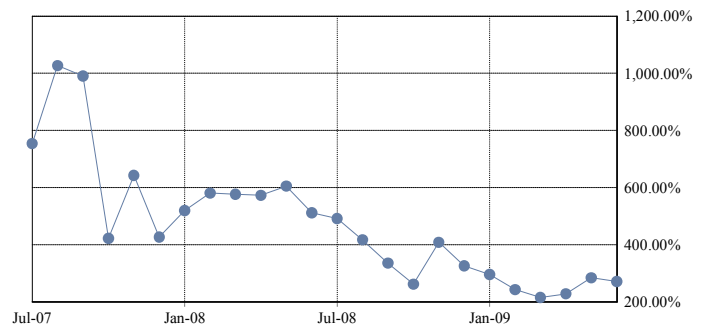
Total CPR



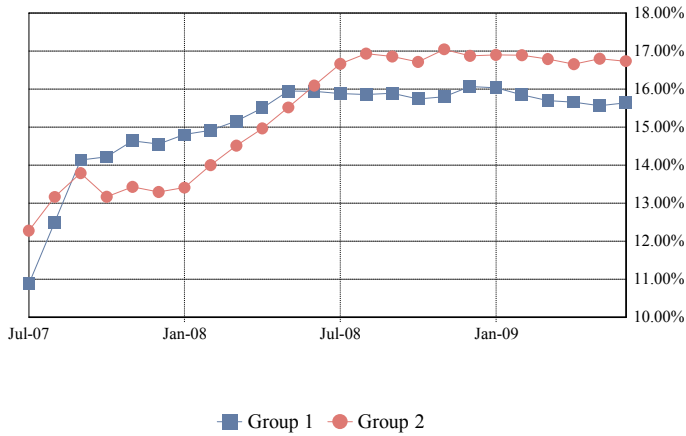
PSA by Groups



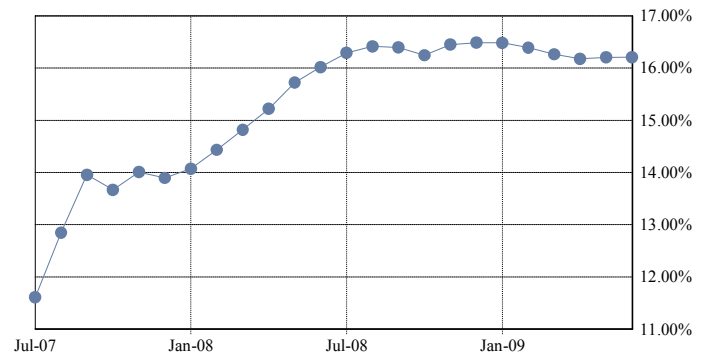

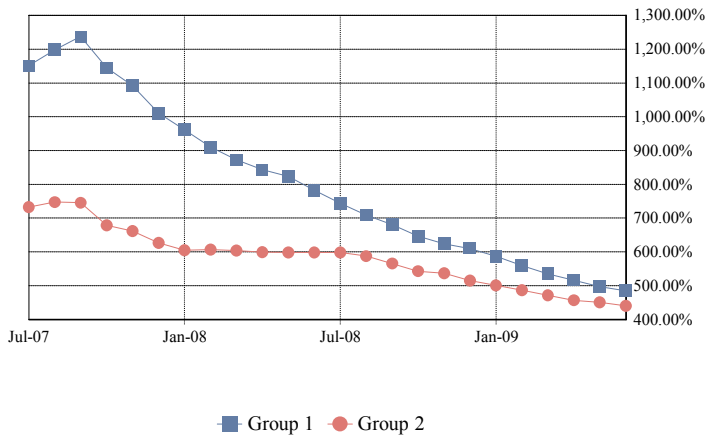
CPR Avg since Cut-Off by Groups



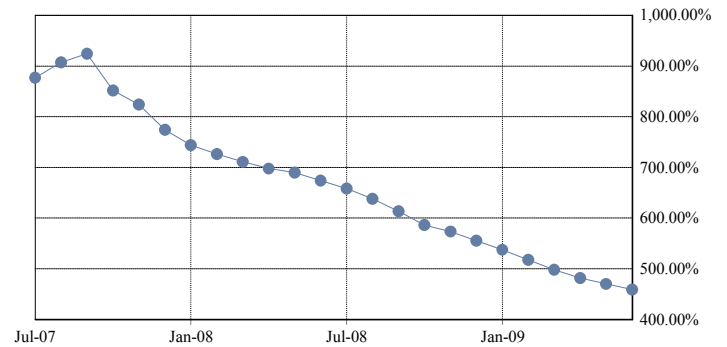

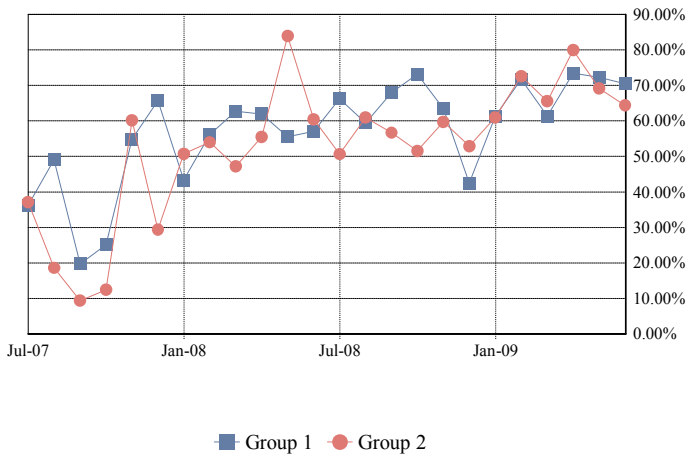

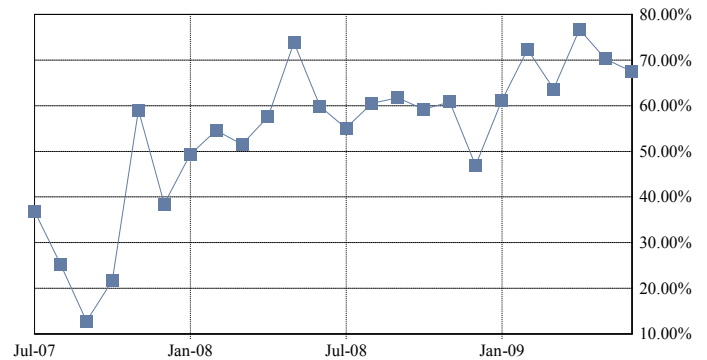

Collateral Loss Severity Approximation by Groups



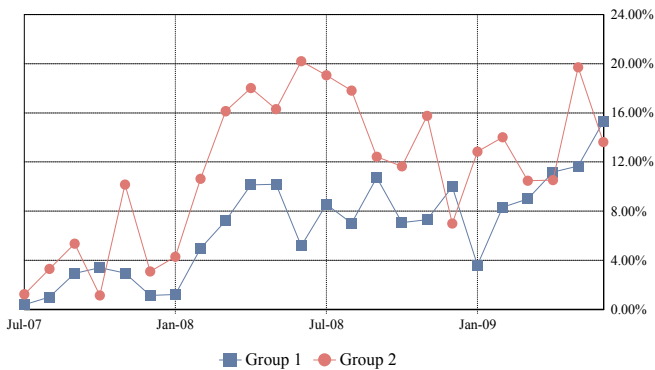

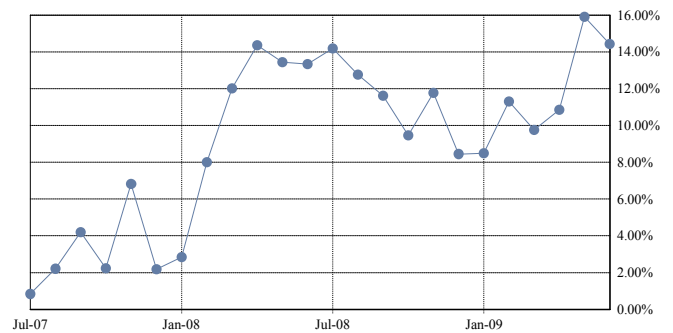

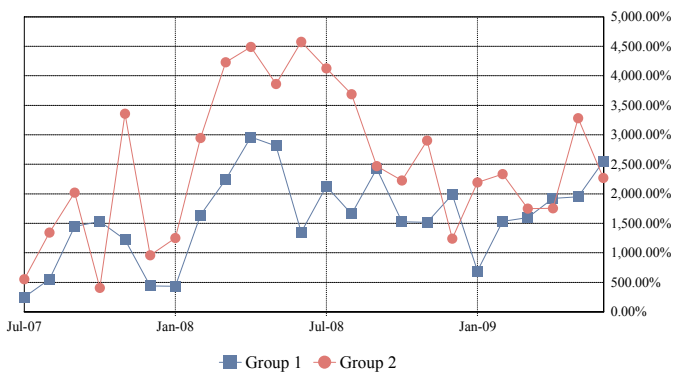
CDR by Groups



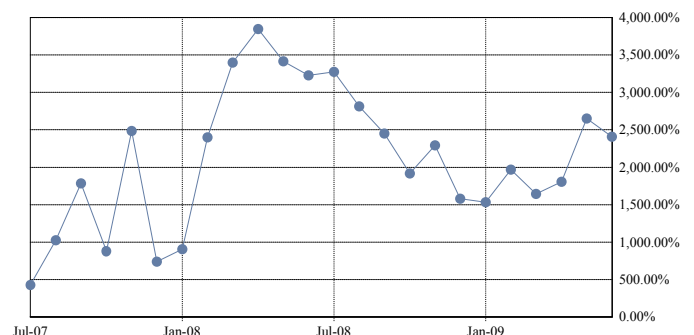
Total CDR



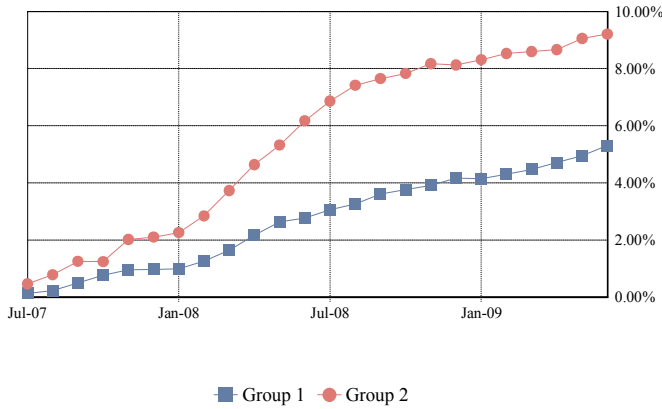
SDA by Groups



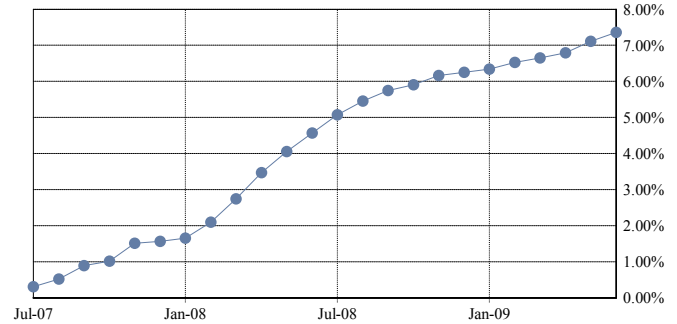

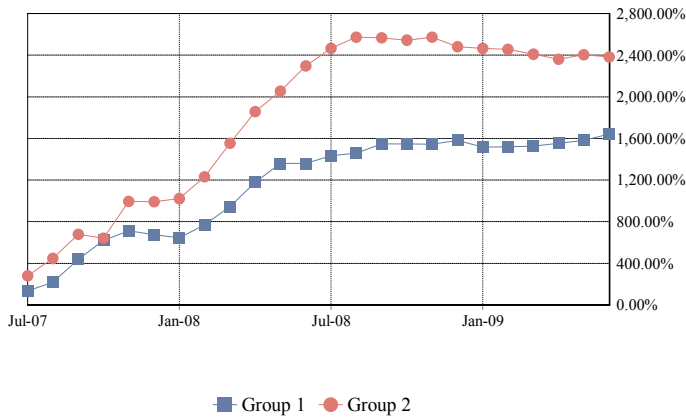
CDR Avg since Cut-Off by Groups



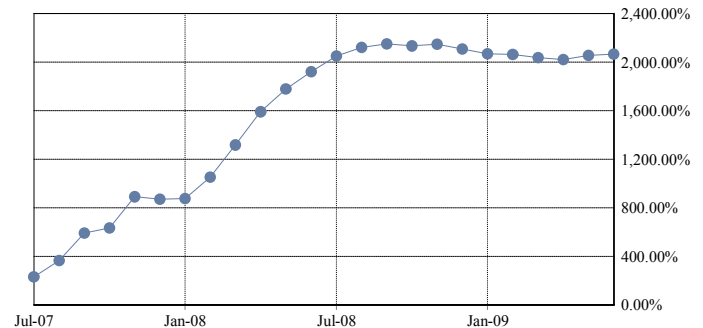
Total CDR Avg since Cut-Off
