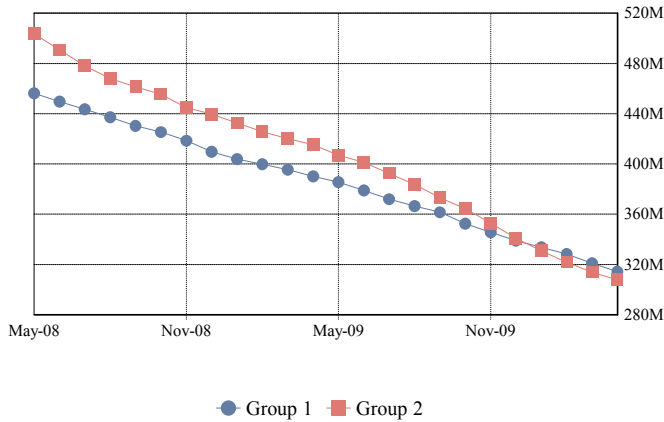

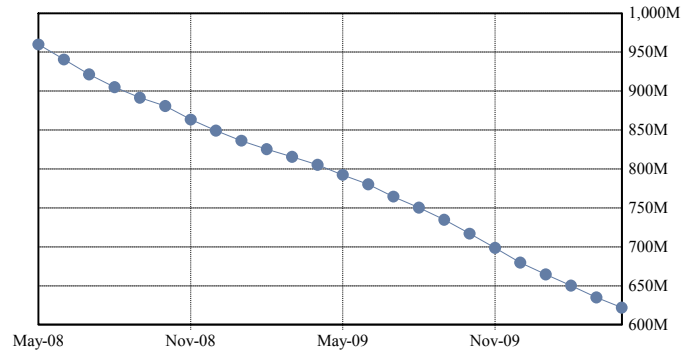

**Current Principal Balance by Groups**



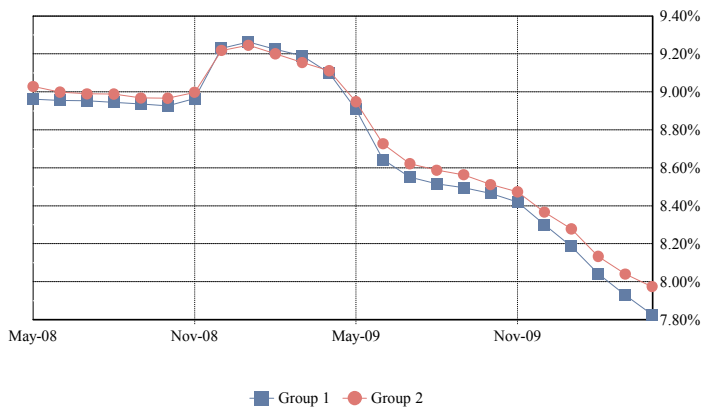

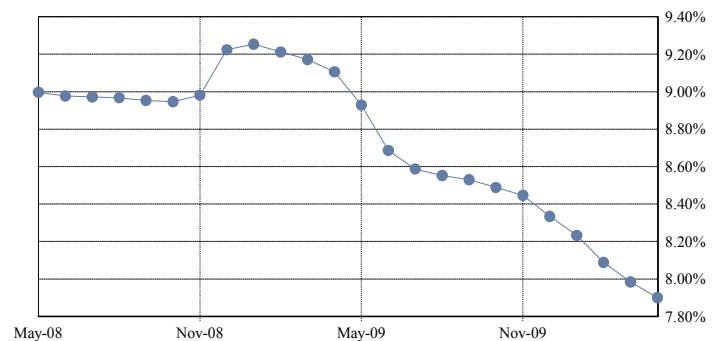

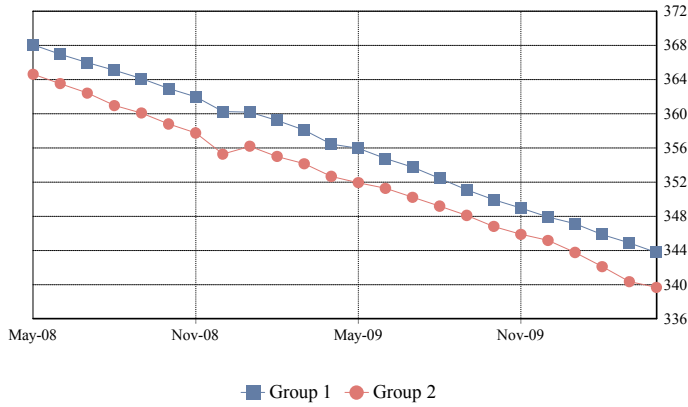
**Weighted Average Coupon by Groups**



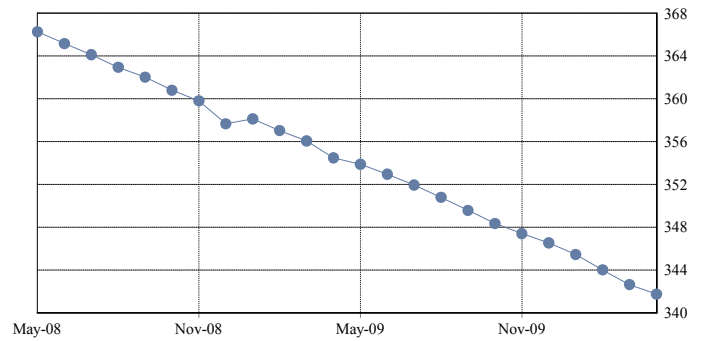
**Total Weighted Average Coupon**

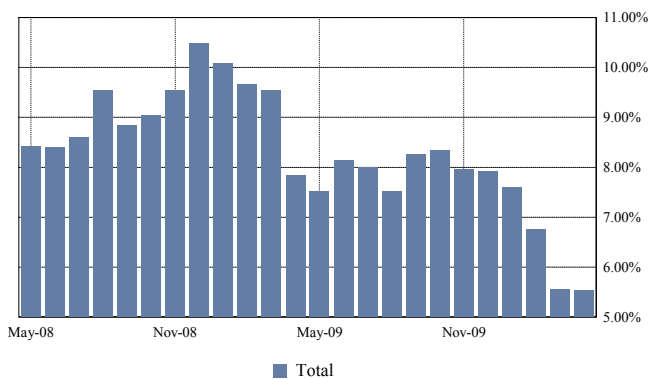

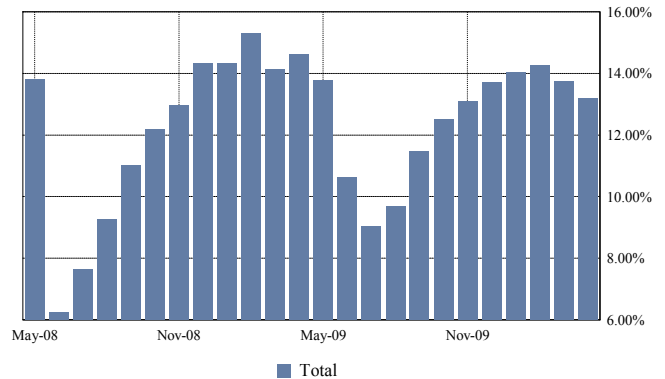

Utilized OTS Delinquency Methodology for Calculating Delinquency Buckets and Amounts

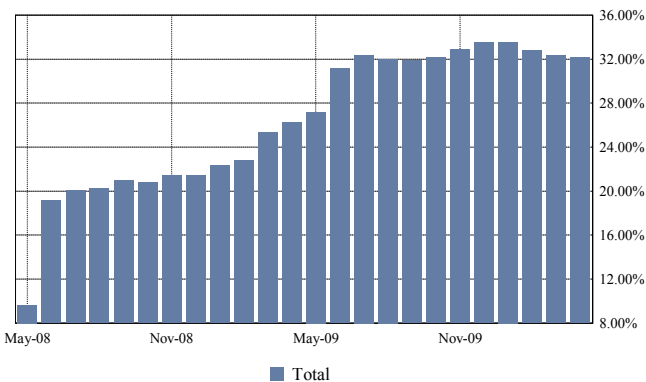
#### 1 or 2 Payments Delinquent



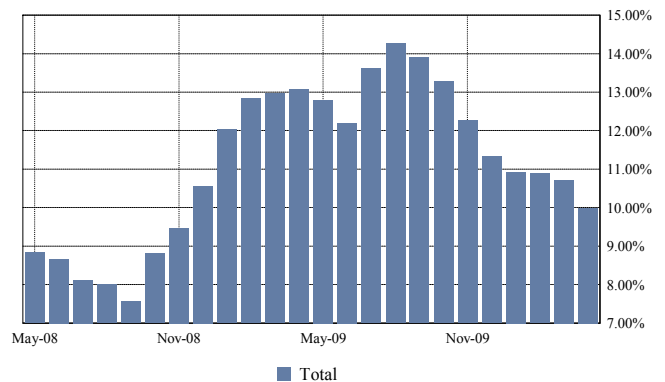

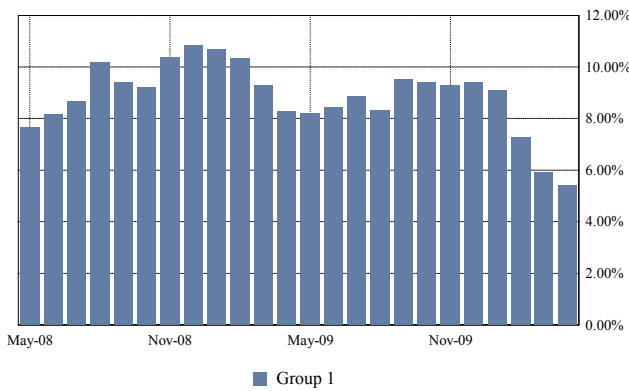

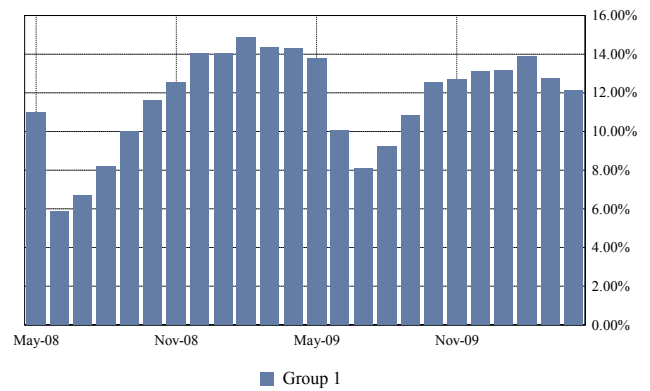

Utilized OTS Delinquency Methodology for Calculating Delinquency Buckets and Amounts

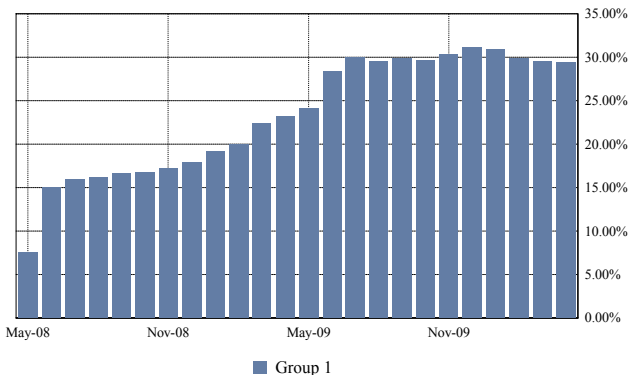
#### 1 or 2 Payments Delinquent



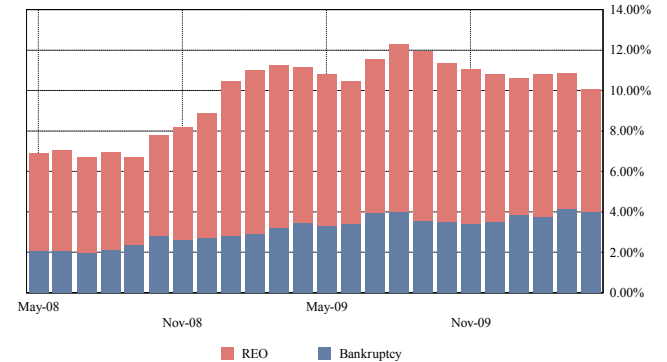
#### 3 or More Payments Delinquent

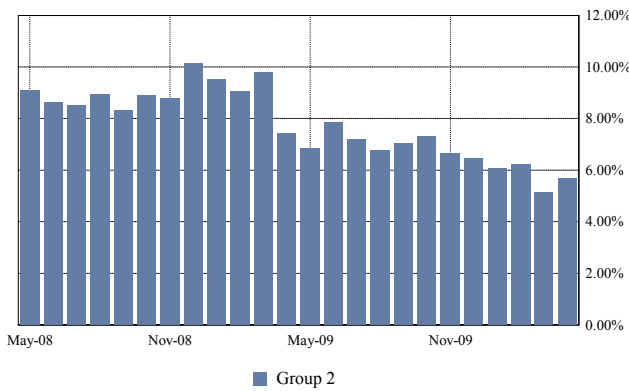

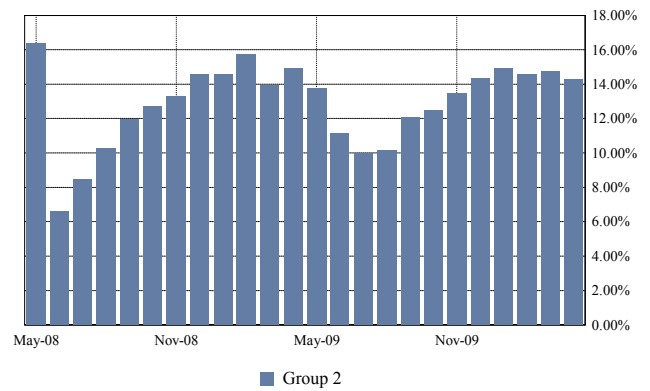

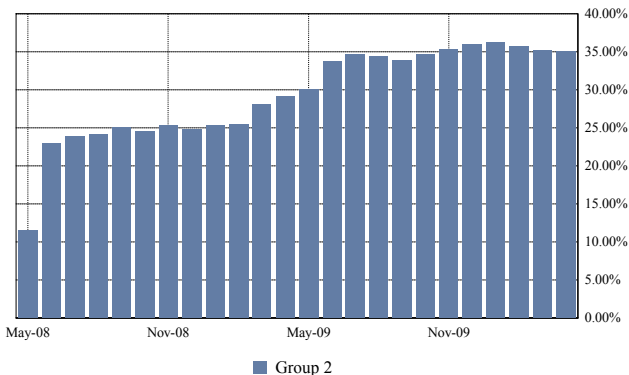
#### 1 or 2 Payments Delinquent



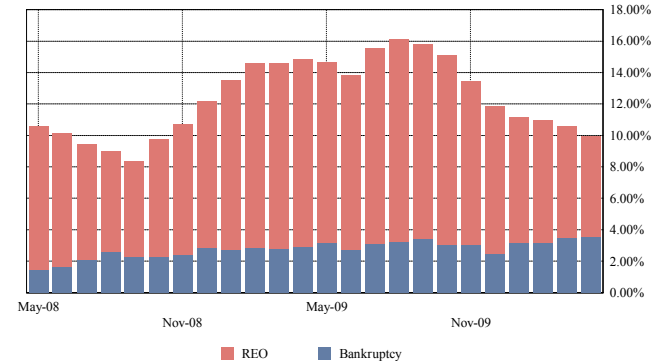
#### 3 or More Payments Delinquent

Collateral Loss Severity Approximation by Groups



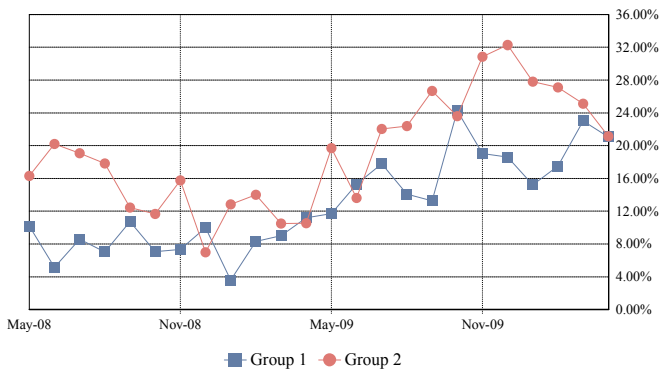
